**2. MINIMUM WAGES**

- (1) With effect from 1 August 2016 an employer must pay an employee, at least the minimum wage prescribed in this clause.

2. Substitute clause 9(1)(a) as reflected in the Government notice R675 of June 2008 with the following:

**9. BOARDING ALLOWANCES**

- (1) If an employer requires an employee to sleep over at a place other than where the employee resides, the employer must either –
- (a) Pay the employee the amount as reflected in table 2 below per night; or employer must arrange accommodation for an employee
